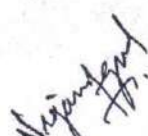

Expression of Interest (Eoi)

Invitation for offering Technical Support to Environment Department on a pro-bono basis from Expert Institution/NGOs/Organisation during January 2025 to June 2025.

Terms of References (TOR):

1. Introduction:

The city of Delhi has a complex urban environment and geographical location which gets severely influenced by its neighbouring states and faces air pollution, predominantly due to high concentration of particulate matter i.e., PM₁₀ and PM_{2.5}. It is also pertinent to note that GNCTD has been taking various stringent actions for air pollution control from last several years but due to geographical constraints, the City of Delhi ends up receiving pollution from neighbouring states, mainly in terms of high levels of particulate matter due to stubble burning.

The Department of Environment (DoE), GNCTD has the responsibility of improving the overall environmental quality in Delhi. This department is identified as a nodal agency for coordination on various environmental issues of Delhi.

The Department of Environment, in coordination with more than 30 stakeholder departments, implements important action plans such as Winter Action Plan, Environment Action Plan 2024-25, Comprehensive Action Plan (CAP), the National Clean Air Programme (NCAP) and also undertakes the implementation of CAQM's Policy to Curb Air Pollution in NCT and implementation of Graded Response Action Plan (GRAP) by CAQM.

In light of this, we are reaching out to expert organizations in the field of air pollution abatement to provide pro-bono support. We seek individuals and teams adept in data-centred work, skilled in coordinating with various governmental and non-governmental entities and equipped with innovative strategies to tackle air pollution. Your expertise in monitoring air quality, analysing data trends, and implementing mitigation measures will be invaluable in our collective efforts to improve Delhi's air quality, during January 2025 to June -2025.

2. Aim & Objectives:

Inviting Expert Institution/NGOs/Organisation to provide technical assistance and backend support (in terms of manpower 02 Nos) to Department of Environment, GNCTD, in conceptualisation, planning, design, development, execution,

deployment, monitoring, evaluation and in such other stages of various activities and programmes as may be required regarding air pollution control on pro-bono basis in the following sectors:

1. Strengthening of Air Quality monitoring and source apportionment
2. Abating Industrial Pollution
3. Abating Air Pollution from DG Set
4. Abating air pollution from the Vehicle and Transport Sector
5. Clean Fuels and Electric Mobility
6. Effective Public Transportation Services
7. Abating air pollution through effective Road Traffic Management
8. Abating air pollution through control of Municipal Solid Waste and Landfill fires /
9. Biomass Burning / Crop residue
10. Management of Construction & Demolition activities to reduce dust
11. Abatement of air and dust pollution from roads and open areas
12. Abating air pollution through Greening and Plantation programs
13. Public Awareness and Citizen Participation
14. Improvement of water quality
15. Policies and Studies
16. Mitigation of Noise Pollution
17. Forest Conservation and Plantation
18. Replication of best practices from other states

3. Scope of Work:

The technical support will mainly include assisting and providing necessary support to DoE in executing various activities and programmes including e-governance tools. The scope of work shall include the activities which may include the following, in any of the above 1 or 2 sectors:

- I. Compilation and analysis of technical data with key findings and recommendations
- II. Coordination with stakeholder departments for implementation of various air pollution control action plans
- III. Preparation and compilation of action taken reports
- IV. Conducting training and public awareness programs
- V. Technical support to the department in state/centre level meetings
- VI. Development of IT Tools/portal for ease of technical data handling
- VII. Carry out key activities as detailed in the Shudh Vayu Sampark (SVS) published by CAQM
- VIII. Analysis, interpretation and visualization of environmental data sets for providing technical support and preparation of reports using the same
