Subject- Withdrawal of direction u/s 31 (A) of Air (Prevention and control of pollution)
Act, 1981,wrt prohibition of operation of Electricity Generator sets run on
Diesel/Petro/Kerosene in NCT of Delhi modification thereof.

Sir,

EPCA, after considering the advise of the Task Force on graded response Action Plan had banned the use of Diesel Generator Sets (other than essential/emergency services) in Delhi and in vicinity towns i.e. Ghaziabad, Noida, Greater Noida, Faridabad and Gurugram from 15th October 2020 onwards. On constitution of Commission on Air Quality Management in NCR and adjoining areas in pursuance to the ordinance dated 28th October 2020, EPCA has being dissolved. Further, as per the direction of the Commission on Air Quality Management in NCR and adjoining areas dated 10th November 2020, Central Pollution Control Board (CPCB) has been authorized to operationalize and monitor GRAP.

As per the forecast and prediction received by CPCB, Air Quality in Delhi- NCR is expected to be better in the coming days due to improved ventilation conditions.

Based on forecast and prediction, CPCB has decided that the ban on use of Diesel Generator Sets in Delhi NCR is lifted with effect from 5th March 2021, which was imposed vide direction dated 14.10.2020 in Delhi.

In view of the above, the direction of even number dated 13.10.2020 with regard to banning of operation of DG sets is hereby revoked with immediate effect.
