- 2. The representative from Weights & Measures stated that all the pending reforms over the RC portal is dependent on the Central Act and a letter has already been sent to the Government of India by the department.
- 3. The representative from DPCC informed that DPCC has also sent a letter to MOEF&CC regarding eliminating the risk of imprisonment for citizens.
- 4. The Chair directed response may be sought from Departments of Forests and Wildlife, Environment & Labour regarding decriminalisation reforms which are still under review. Further, a letter should be sent to DPIIT regarding the compliances which are dependent to the Central Acts after getting responses from the stakeholder departments.

 - a. To conduct study of the Regulatory Compliance Portal regarding the initiatives taken by other states (best practices) and provide recommendations/suggestions to the department accordingly.
 - b. Industries Department shall also share the best practices to GNCTD Departments, which was shared by the DPIIT.
