

I. Plan Scheme

The Department of Environment under its following plan scheme provides grant in aid to NGOs / RWAs for undertaking action oriented projects/proposals in the field of Environment for beneficiaries of weaker section of society under Schedule Caste Category:

INVOLVEMENT OF WEAKER SECTION OF SOCIETY FOR IMPROVEMENT AND UPGRADE OF ENVIRONMENT(SCSP)

II. Objective of Scheme

To utilize the expertise available with registered NGOs/ RWAs, which are engaged in action oriented environment related activities involving weaker section of society of the Environment in NCT of Delhi, by providing them financial assistance.

III. Who Can Apply

Non - Governmental Organizations (NGOs), Residents Welfare Associations (RWAs):

- Engaged in environmental awareness, waste management, promotion of eco-friendly material and other related environmental activities in NCT of Delhi, for a minimum period of 3 years
- Registered under Societies Registration Act, 1860 (Act XXI of 1860) or a public trust registered under appropriate law for the time being in force
- Have Unique Identification generated by NGO-Darpan Portal

IV. How to Apply

The format for applying for grant-in-aid and other relevant guideline is available on website of Department of Environment GNCTD at www.environment.delhigovt.nic.in under the said plan scheme content.

V. Documents to be Attached with the Proposal

The proposal from NGOs / RWAs shall be accompanied by the following documents (Self attested copy) :

- Complete registration documents and Unique Identification generated by NGO - Darpan Portal
- Profile of the Organization
- Details of previous experience in the field of environment including evidence of completed work
- Last three years account statement, receipt & payments and balance sheet with auditor certificates

VI. Proposal Submission Date

On or before 15 April of the financial year

The proposal may be submitted at Department of Environment, GNCTD, 6th Level, C-Wing, Delhi Secretariat, IP Estate, New Delhi-110002.


