ORDER

In pursuance to letter no. EPCA-R/2017/L-60 dated 16.11.2017 of Environment Pollution (Prevention and Control) Authority, approval of Hon'ble Lt. Governor, and order dated 17-11-2017 of Hon'ble NGT in O.A. No 21 of 2014, the order No. F10 (32)/Env/2016/653-690 dated 08-11-2017 and order No. F10(44)/Env/2017/Pt. File-3/6197-6233 dated 16-11-2017 issued by DPCC is hereby further modified with following amendment:-

1. Ban on Civil Engineering Construction & Demolition activities in the Delhi is lifted. Accordingly, directions issued vide letter No. DPCC/MS/2016/AP/5871-87 dated 09-11-2017 under section 31(A) of Air (Pollution and Control of Pollution) Act 1981 read with Rule 20A(6) of the Air (Pollution and Control of Pollution) (Union Territories) Rules, Act 1983 to stop all Civil Engineering Construction and Demolition activities in Delhi stands null and void.

Further, the remaining decisions as contained in the previous orders issued by DPCC dated 08-11-2017 and 16-11-2017 as indicated above will remain enforced.
